ARTICLES OF INCORPORATION

OF

COMMONWEALTH INSURANCE COMPANY
 (As amended, January 30, 1985)

KNOW ALL MEN BY THESE PRESENTS:

That we, a majority of whom are residents of the Philippines, have this day voluntarily associated ourselves for the purpose of forming a corporation under the laws of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of the said corporation shall be COMMONWEALTH INSURANCE COMPANY

SECOND: That the purpose for which the corporation is Securifies and formed are the following: change

the company and to carry on any kind of business necessary or expedient for any such purpose.

(6) To insure against every description of marine risk, which may legally be undertaken, relating to the perils of the sea, fire, war reprisals, and all other risks of a like nature, incidental to the seas, ships, vessels, and water craft of all descriptions, and also the freights, merchandise, cargo and all property of members of company or not, so far as the same may affected or made according to law. To insure all other matters and things which lawfully may or can be from time to time insured or be the subject of insurance against perils of the sea, and also generally to carry on any other branches and departments of the insurance business.

(b-1) To grant either in the Philippines or abroad, policies or instruments of assurance against or insuring compensation of payment in case of death or injury to health of limb by railway or airplane actident or shipwreck or other perils of the Cland, sea or air. accident of misadventure or violence during any journey voyage water or air, or during any other limited or specified period; and to prepare, provide and medicines and surgical aid and treatment or any other assistance and all remedies and requirements in any case of accident or harm to any person or the family and household of any person whom, the company shall insure or to any person dwelling or staying in the house of such person insured. (as

amended on February 2B, 1939).

- (c) To reinsure all or any risks of the company and to undertake all kinds of reinsurance and counterinsurance connected with the business of any other company.
- (d) To guarantee the fidelity of persons holding places of public or private trust.
- (e) To guarantee the performance of contracts, agreements, undertakings, obligation, promises or duties of all kinds other than insurance policies.
- (f) To guaranty the performance of insurance contracts where surety bonds are accepted for such purpose.
- (g) To execute and to quarantee bonds and undertaking of all kinds, required or permitted to be taken in any or all actions, proceedings, negotiations, importations, exportations, or other transactions or operations either by private individuals, or by heads of departments, courts, judges, officers, boards or bodies whether executive, legislative or judicial:
- (h) To guarantee and ito indemnify merchants, traders and those engaged in business and giving credit, from loss or damage by reason of giving and extending such credit to their customers or persons dealing with them.
- (i) To indemnify against loss by gurglary, theft, pru_lsecexpress, embezzlement, or by any one or more of such happenings.
 - (j) To insure glass against breakage.
 - (k) To guarantee and to indemnify the owners and users

of all kinds of machinery, against explosions or other accident against loss or damage to life or property resulting therefrom, and against loss of use or occupancy caused thereby, and against liability unto third persons by any of said causes; and to make inspection of, and to issue certificates of inspection upon, such boilers, pipes, flywheels, engines and machinery.

- (1) And generally to execute, sign and carry fidelity bonds and surety undertaking of every nature, and kind usual in the business of fidelity and surety companies.
- (m) To lend money on such terms as may seem expedient, subject to the requirements of law.
- (n) To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or company carrying on any business which this company is authourized to carry on preproperty suitable for the purpose of this company.
- (a) To acquire by purhase and to invest in, hold, sell or otherwise dispose of the stocks or bonds, or any interest in either, or any obligations or evidences of indebtedness, of any corporation or produce of indebtedness, of any corporation or other obligations or evidences of indebtedness, of any person, firm or corporation, and while the owner of such stocks, bonds or interest therein, or other obligations or evidences of indebtedness.


