

AMENDED ARTICLE OF INCORPORATION OF

COMMONWEALTH INSURANCE COMPANY

(As amended, January 30, 1985)

KNOW ALL MEN BY THESE PRESENTTS:

That we, a majority of whom are resendents of the Philippines, have this day voluntarily associated ourselves for the purpose of forming a corporation under the the laws of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of the said corporation shall be

COMMONWEALTH INSURANCE COMPANY

SECOND: That the purpose for which the corporation is formed are the following:

- (a) To insure houses, tenements, merchandise and all other property and effects, real and personal, against loss or damage by fire; storm, earthquake, accident or otherwise, and to carry on the ordinary business of fire insurance in all aforesaid brances. To rebuild, repair replace or reinstate houses, buildings, machinery and every other description of property which may be insured by the company and or expedient for any such purpose.
- (b) To insure against every description of marine risk, which may legally be undertaken, relating to the perils of the sea, fire, war reprisals, and all 'other risks of a like nature, incidental to the seas, ships, vessels, and water craft of all description, cargo and all property of members of the company or not, so far as the same may be affected or made according to law. To insure all other matters and things which lawfully may or can be from time to time insured or be the subject of insurance against perils of the sea, and also generally to carry on any other brances and departments of the insurance business.
- (b-1) To grant either in the Philppines or abroad, policies or instruments of assurance againts or insuring compensation of payment in case of death or injury to health of limb by railway or airplane accident or shipreck or other perils of the land,sea, or any other accident of misadventure or violence during any journey or voyage by land or water or air, or during any other limited or specified period; and to prepare, provide and supply medicines and surgical aid and treatment or any other assistance and all remetance and all remedies and requirments in any case of sccident or harm to any person or the family and household of any person whom the company shall insure or to any person dwelling or staying in the house of such person insured. (as amended on Febuary 28, 1939).

- (c) To reinsure all or any risks of the company and to undert5ake all kinds of reinsurance and counter-insurance connected with the business of any other company.
- (d) To guarantee the fidelity of persons holding places of public or private trust.
- (e) To guarantee the performance of contacts, agreements, undertakings, obligation, promises or duties of all kinds other than insurance policies.
- (f) To guaranty the performance of insurance contracts where surely bonds are accepted for such purpose.
- (g) To execute and to guarantee bonds and undertaking of all kinds, required or permitted to be taken in any or all actions, proceeding, negotiations, or operations either by private individuals, or by heads of departments, courts, judges, officers, boards or bodies whether executive, legislative or judicial.
- (h) To guarantee and to indemnify merchants, traders and those engaged in business and giving credits, from loss or damage by reason of giving and extending such credit to their customers or persons dealing with them.
- To indemnify againts loss by gurglary, theft, forgery, embezziement, or by any one or more of such happenings.
- (j) To insure glass againts breakage.
- (k) To guarantee and to indemnify the owners and users of steam boilers and pipes, of flywheels, engines of all kinds of machinery, againts explosions or other accidents againts loss or damage to life or property resulting therefrom, and againts liability unto third persons by any of sald causes; and to make inspection of, and to issue certificates of inspection upon, such boilers, pipes, flywheels, engines and machinery.
- And generally to execute, sign and carry fidelity bonds and surely undertaking of every nature and kind usual in the business of fidelity and surely companies.
- (m) To lend money on such terms as may seem expedient, subject to the requirements of law.
- (n) To purchase or otherwise acquire and undertake all or any part of the business, property and liabilities of any person or company carrying on any business which this company is authorized to carry on or property suitable for the purpose of this company.
- (o) To acquire by purchase and to invest in, hold, sell or otherwise dispose of the stocks or bonds, or any interest in either, or any obligations or evidence of indebtedness, of any

corporation or corporations, domestic or foreign, on the bonds or other obligations or evidence of indebtedness, of any person, firm or corporation, and while the owner of such stocks, bonds or interest therein, or other obligations or evidences of indebtedness to exercise all the rights, powers and priviledges of ownership, including the right to vote thereon or consent in respect thereof for any and all purpose.

- (p) To purchase or otherwise acquire, sell, lease, convey, mortage, encumber and otherwise deal withany propert or interest or easement, right or priviledge over or in respect of any property, real or personal as may be permitted by law and as may be reasonable necessary to enable it to carry out the purpose for which the corporation is created as may now or hereafter be permitted by law.
- (q) To procure the company to be registered or recognized or be permitted or allowed to carry on its business or any branch or brances thereof in any State, Territory, or possession of the United States and / or in any foreign country of places; and in carrying on its business to do any and all acts and things and exercise any and all powers which a natural person could do or exercise which now or hereafter may be authorized by Law.
- (r) To do all or any of the above things in any place in which the company may determine as principals, agents, contractors, trustees or otherwise and either alone or in conjunction with others.
- (s) To do all such other things as are incidental or conducive to the attainment of the above objects.
- (t) To do and perform any and all of the acts and things and to exercise all of the general powers conferred by law upon corporations similarly organized and usually and ordinarily incidental to companies of like nature and kind.
- (u) And in general, to engage in the business of insurance and guaranty in any bran ches except in life insurance business, for a consideration, to indemnify any person, firm or corporation againts loss, damage or liability arising from an unknown or contogent event, and to guarantee liabilities and obligations of any person, firm or corporation, and to act as agent of other insurance or survey company, in any of its branches, with the exception of life insurance.

THIRD: That the place where the principal office of the corporation is to be established or located is in the Municipality of Makati, Province of Rizal, Philippines (as amended on 4 May 1971)

FOURTH: That the term for which said corporation is to exist is extend for another fifty years from and after December 26 1985 expiry date of its original term .(As amended, January 30, 1985)
